What Europe is or should be, then cannot be conjured up from the past; it has to be developed as a political response to the questions of the future, in every field such as the labor market, ecology and the social state, international migration, political freedoms and basic rights". Ulrich Beck 2020

Questions

- How can we combine the pluralistic and complex sense of belonging by individuals, groups, and peoples in order to construct a political identity that is purportedly European, or rather, to arouse identification with Europe as a new political space of action and demands?
- How can we manage to form a European public identity accompanied by an identification with a "European political culture" in which other identities – ethnic, religious, regional, even national – would be considered as private identities?
